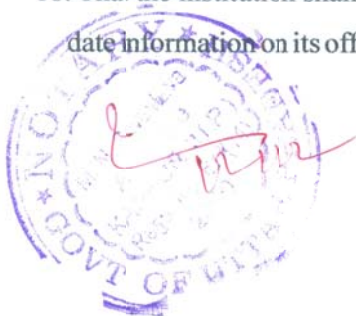


Undertaking

4. That in addition to the above the infra structural instructional and other facilities are provided as per the NCTE Regulations, norms, standards and guidelines prescribed from time to time.

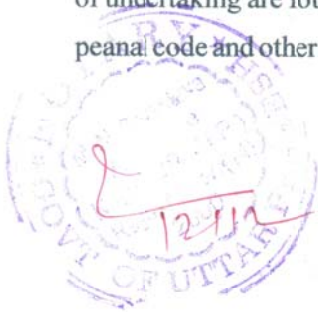
6. That admission to the course is being done as per norms of NRC, Jaipur and after affiliating has been granted by C.S.J.M. University, Kanpur, U.P.

8. That there is reservation of seats for SC/ST/OBC other categories of the state Govt./the affiliating University.
9. That the supporting and other staff is appointed as per the guidelines of the state Govt. the affiliating.
10. That the institution is charging only such fee as prescribed by the affiliating body/state govt. concerned in accordance with provision of NCTE (guidelines for regulations of tuition fees and other fees chargeable by unaided teacher education institution) Regulations, 2002, as amended from time to time and shall not charge donations, capitation fee etc, from the students.
11. That the academic and other staff of the institution (including part time staff) is being paid such salary as has been prescribed by the concerned state govt./Unieversity from time to time through bank.
12. That the management shall discharge the self-financed college statutory obligations relating to prominent fund, pension, gratuity etc. in respect of all its employees as per norms.
13. That the management has created adequate fund suitable for providing satisfactory facilities and for proper program implementation if required the management will make adequate funds in future also.
14. That the account of the institutions properly maintained and audited annually by the authorities or a chartered accountant and will be open for inspection.
15. That the management is strictly following all condition and norms prescribed by NCTE from time to time, Conduct the programmed in all, and submit itself inspection by the NCTE.
16. That the institution shall make the information or documents available to the NCTE or its authorized representatives as and when required by them. Failure to produce or show any of the required documents, shall be treated as a breach of the conditions of recognition.
17.
